

#### FUNCTIONS & RESPONSIBILITIES OF VARIOUS INSTITUTIONAL MEMBERS:

**Governing Body:** In administrative and decision making, the Governing Body is the sole authority of the college. The Governing Body of the College is composed as per the guidelines issued by Government of Assam wherein one President, selected by the Government, one Secretary, V.C Nominee, Guardian Representative, Teachers' Representatives, Local M.L.A, Librarian and one Office Staff are there. The Body seats in the meeting called by the secretary and deals with the financial position, expenditure, appointment, increment, faculty promotion etc..

**Principal**: The Principal is the Head of the Institution and look after the administration and Academic performance. The Principal of the college is the sole authority for implementing of the decisions taken in the Governing Body Meeting.

**Internal Quality Assurance Cell:** The Institution has an Internal Quality Assurance Cell established as per latest guidelines of NAAC. It was established in the year 2004. The present members of the Cell is comprised all the representations from different stakeholders. The IQAC of the college works as per the guidelines designed and developed by NAAC. It holds it meetings in every quarter and takes decisions on academic and extra-curricular activities. It designs and develops yearly plans for every academic session.

**Department Conveners:** The Department Conveners are the members that may be other than the department Head. The Head of the Institution holds meetings with the Conveners to know the curricular and co-curricular activities and Continuous Internal Evaluations.

**Librarian:** The Librarian of the Central Library has overall responsibility for the maintenance of library. The library has a Committee i.e. the Library Committee with Teacher Representatives holds meeting frequently to take decisions on library development.
