Mechanism to Deal with the Internal Exam Related Grievances:

The internal examination related grievances of the college is dealt with the following mechanisms:

AT COLLEGE LEVEL:

At college level the Internal Assessment related grievances are dealt with the following mechanisms:

- ➤ The college has a policy for those students who are not able to appear in Internal Assessment examination due to genuine ground viz., medical or any other family related ground, with proper application, allowed to appear in the Sessional examinations.
- ➤ There is provision for slow learners, who scores less marks in the Internal Assessment examination, to reappear in the examination for improvement in examination.
- ➤ The grievances and action taken policy at the college level are shown in the departmental answer sheet.
- For the answer script of the student, those who scores less marks in Internal Assessment examinations are shown to the student in their presence and options are provided for betterment to seat again in the examination.
- Any student not satisfied with his/her marks given by the concerned teacher are allowed to approach the HoD of concern Department for grievance redresses.
- ➤ The college follows a transparent policy for evaluation where marks of the students are shown in the concerned class and in Notice Board.

AT UNIVERSITY LEVEL:

➤ In reference to the internal examination marks entry in final examination mark sheets provided by the university is less than the marks provided by the college, then application are sought from the students and the same has been forwarded by the Principal to the Controller of Examination of the Parent University for grievance redresal with due formalities.
